Recitals:

WHEREAS, Party A desires to engage Party B to provide certain services and Party B agrees to provide such services under the terms and conditions set forth herein; AND WHEREAS, both parties desire to enter into this Agreement to define their rights and obligations.

Section 1 – Services Provided

Party B agrees to provide the services (the “Services”) as described in the attached Schedule A. All services shall be performed in a professional and workmanlike manner in accordance with industry standards.

Section 2 – Term and Termination

This Agreement shall commence upon execution by both parties and continue until terminated by either party upon thirty (30) days prior written notice. Termination shall not affect payment obligations for services rendered prior to termination.

Section 3 – Compensation

Party A shall pay Party B as outlined in Schedule B attached hereto. Payments shall be due within fifteen (15) days of receipt of invoice. Late payments shall accrue interest at the rate of one and one-half percent (1.5%) per month or the maximum rate permitted by law.

Section 4 – Confidentiality

Each party agrees that all confidential information disclosed shall be kept confidential and used solely for the purpose of performing obligations under this Agreement. This obligation survives termination of this Agreement.

Section 5 – Intellectual Property Rights

All intellectual property developed or delivered by Party B under this Agreement shall be the sole property of Party A upon full payment, except for pre-existing materials of Party B which remain its sole property.

Section 6 – Representations and Warranties

Each party represents and warrants that it has the authority to enter into this Agreement and that performance hereunder

shall not violate any applicable law or third-party rights.

Section 7 – Indemnification

Each party agrees to indemnify, defend and hold harmless the other party from any claims, liabilities, damages, or expenses arising out of or related to any breach of this Agreement or negligence.

Section 8 – Limitation of Liability

In no event shall either party be liable for any indirect, incidental, special, or consequential damages arising out of or related to this Agreement, even if advised of the possibility thereof.

Section 9 – Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflict of law principles. The parties consent to exclusive jurisdiction and venue in the state and federal courts located in _____ County, _____.

Section 10 – Dispute Resolution

Any dispute arising out of or related to this Agreement shall first be subject to good faith negotiation between the parties. If unresolved, disputes shall be resolved by binding arbitration administered in accordance with the rules of the American Arbitration Association.

Section 11 – Entire Agreement

This Agreement, including all Schedules and Exhibits, constitutes the entire agreement between the parties and supersedes all prior agreements and understandings.

Section 12 – Amendments

No amendment or modification shall be effective unless in writing and signed by both parties.

Section 13 – Notices

All notices shall be in writing and delivered by hand, certified mail, overnight courier, or email with confirmation to the addresses specified herein or as updated by written notice.

Section 14 – Force Majeure

Neither party shall be liable for any failure or delay in performance due to causes beyond its reasonable control, including but not limited to acts of God, war, terrorism, strikes, or government action.

Section 15 – Severability

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Section 16 – Waiver

Failure to enforce any provision of this Agreement shall not constitute a waiver of any other provision or future enforcement rights.

Section 17 – Assignment

Neither party may assign or transfer this Agreement without the prior written consent of the other party, except to a successor entity in the event of a merger or sale.

Section 18 – Relationship of Parties

The parties are independent contractors. Nothing in this Agreement creates a partnership, joint venture, or employment relationship.

Section 19 – Counterparts and Electronic Signatures

This Agreement may be executed in counterparts and by electronic means, each of which shall be deemed an original and all of which together constitute one agreement.

Section 20 – Compliance with Laws

Both parties agree to comply with all applicable federal, state, and local laws, regulations, and ordinances in performing their obligations under this Agreement.
