Licensee shall indemnify and hold harmless Licensors from any claims, damages, liabilities, costs, and expenses arising from Licensee's use of the Artwork beyond the scope of this Agreement or in violation of applicable law.

Limitation of Liability:

In no event shall Licensors be liable for any indirect, incidental, consequential, or punitive damages arising out of or relating to this Agreement or Licensee's use of the Artwork.

Confidentiality:

The parties agree to keep confidential all non-public information disclosed in connection with this Agreement and not to disclose such information except as required by law or with prior written consent.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflict of law principles. The parties consent to the exclusive jurisdiction and venue of state and federal courts located in _____ County, _____.
