ENGAGEMENT AND TERM:

Manager is hereby engaged as the exclusive personal manager of the Artist for all aspects of Artist's career in the entertainment industry, including but not limited to music recording, publishing, live performances, merchandising, endorsements, and other related activities, within the Territory defined as the United States of America. The term of this Agreement shall commence on the Effective Date and continue until terminated in accordance with the provisions herein.

MANAGER'S DUTIES:

Manager shall use reasonable efforts to advise, counsel, guide, and direct the Artist in the development and advancement of Artist's career, including negotiating and securing agreements, contracts, and engagements on behalf of Artist, subject to Artist's final approval. Manager shall keep Artist informed of all material matters and shall account to the Artist for all monies received on Artist's behalf.

ARTIST'S DUTIES:

Artist agrees to cooperate fully with Manager, to keep Manager informed regarding all business activities related to Artist's career, and to refer all business opportunities related to Artist's professional activities to Manager. Artist shall not engage any other personal manager or agent for the services covered by this Agreement during the term without Manager's prior written consent.

COMPENSATION:

Artist agrees to pay Manager a commission of _____% of the Gross Income received by Artist from all entertainment-related activities during the term of this Agreement and for a period of 24 months following termination with respect to engagements or contracts secured during the term. Gross Income includes all monies received by Artist, whether directly or indirectly, from record sales, performances, royalties, merchandising, endorsements, and other related sources.

EXPENSES:

Manager shall not be obligated to pay any expenses incurred on behalf of Artist without prior written approval by Artist. Artist shall reimburse Manager promptly for all approved expenses incurred. Manager will provide reasonable documentation upon request for such expenses.

INDEPENDENT CONTRACTOR:

Manager is an independent contractor and not an employee, partner, or joint venturer of Artist. Nothing herein shall be construed to create any agency, partnership, or employment relationship other than that of personal manager.

TERMINATION:

Either party may terminate this Agreement upon ____ days' written notice to the other party. Termination shall not affect Manager's right to commissions with respect to agreements made or income earned prior to termination and for the post-termination period specified herein.

CONFIDENTIALITY:

Both parties agree to keep confidential and not disclose to third parties any confidential information obtained during the term of this Agreement, except as required by law or with prior written consent.

INDEMNIFICATION:

Each party agrees to indemnify, defend, and hold harmless the other party from any claims, damages, or liabilities arising out of any breach of this Agreement or the gross negligence or willful misconduct of the indemnifying party.

GOVERNING LAW AND VENUE:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflict of law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____ for any disputes arising out of or relating to this Agreement.

ENTIRE AGREEMENT:

This Agreement represents the entire understanding between the parties and supersedes all prior agreements, negotiations, and understandings, whether oral or written. Any amendments must be in writing and signed by both parties.

SEVERABILITY:

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect, and the invalid provision shall be replaced by a valid provision that most nearly reflects the parties' original intent.

NOTICES:

All notices under this Agreement shall be in writing and deemed given when delivered personally, by certified mail return receipt requested, nationally recognized overnight courier, or by electronic means capable of confirming transmission and receipt, to the parties' addresses set forth above or to such other address as a party may designate by notice.

WAIVER OF JURY TRIAL:

TO THE MAXIMUM EXTENT PERMITTED BY LAW, EACH PARTY KNOWINGLY AND VOLUNTARILY WAIVES ANY RIGHT TO A TRIAL BY JURY IN ANY DISPUTE ARISING OUT OF OR RELATED TO THIS AGREEMENT.
