Term and Scope of Agreement:

This Agreement sets forth the terms and conditions under which the Athlete agrees to provide athletic services to the Organization. The term of this Agreement shall commence upon execution and continue for the period mutually agreed upon in writing by both parties. Athlete agrees to perform services to the best of their abilities and in accordance with all applicable rules, regulations, and standards.

Compensation and Benefits:

Organization agrees to compensate Athlete as follows: Base salary, bonuses, incentives, and any other agreed upon remunerations. All payments are subject to applicable tax withholdings and deductions in accordance with United States law. Athlete shall be entitled to benefits as specified in the attached Schedule A, incorporated herein by reference.

Duties and Obligations:

Athlete agrees to maintain physical fitness, attend training sessions, participate in competitions, and comply with all rules and codes of conduct established by the Organization and relevant governing bodies. Athlete shall not engage in any conduct that could bring disrepute or harm to the Organization.

Injuries and Medical Treatment:

Athlete acknowledges the risks inherent in athletic competition and agrees to obtain and maintain appropriate health insurance coverage. Organization agrees to provide reasonable medical support and treatment for injuries sustained during the course of official activities, subject to applicable policies.

Termination:

Either party may terminate this Agreement at any time for cause, including but not limited to material breach,

misconduct, or inability to perform. Termination must be effected by written notice delivered to the other party. Upon termination, all rights and obligations shall cease except as otherwise provided herein.

Confidentiality and Publicity:

Athlete agrees to maintain the confidentiality of all proprietary, confidential, or sensitive information obtained during the course of this Agreement. Organization grants Athlete permission to use name, image, and likeness for promotional purposes consistent with Organization policies and applicable laws.

Compliance with Laws and Policies:

Athlete agrees to comply with all applicable federal, state, and local laws, as well as the rules, regulations, and policies of the Organization and relevant governing bodies, including anti-doping regulations.

Dispute Resolution:

Any disputes arising under or relating to this Agreement shall be resolved first through good faith negotiation between the parties. If unresolved, disputes shall be submitted to binding arbitration in accordance with the rules of the American Arbitration Association or another mutually agreed upon forum.

Indemnification and Liability:

Athlete agrees to indemnify and hold harmless the Organization and its agents from any claims, damages, or liabilities arising out of Athlete's breach of this Agreement or negligent or intentional misconduct.

Miscellaneous Provisions:

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements. No modification shall be binding unless in writing and signed by both parties. If any provision is found unenforceable, the remainder shall remain in full force and effect. This Agreement shall be governed by the laws of the State of _____ without regard to conflict-of-law principles.
