Services to Be Provided:

Babysitter agrees to provide child care services including but not limited to supervising the child(ren), feeding, engaging in age-appropriate activities, assisting with homework, and putting the child(ren) to bed if applicable. Babysitter shall perform services in a safe, attentive, and professional manner.

Schedule and Duration of Services:

The babysitting services shall be provided at the agreed upon times and dates. Any changes to the schedule must be mutually agreed upon in advance by both parties.

Payment Terms:

Parent/Guardian agrees to pay Babysitter at the rate agreed upon by both parties. Payment shall be made promptly after each babysitting session or as otherwise agreed. No taxes or other fees are included unless expressly stated.

Emergency Procedures and Medical Care:

Babysitter shall take reasonable steps to contact Parent/Guardian immediately in case of emergency. Babysitter is authorized to seek and consent to emergency medical treatment for the child(ren) if Parent/Guardian cannot be reached, provided that Babysitter acts in the best interests of the child(ren) and retains all receipts and reports.

Safety and Conduct:

Babysitter shall maintain a safe environment and follow all applicable laws and regulations. Babysitter shall not use

alcohol, illegal substances, or any form of tobacco while providing services. Babysitter shall not engage in any conduct that could endanger the child(ren) or damage the reputation of Parent/Guardian.

Confidentiality:

Babysitter agrees to keep all information regarding the child(ren), household, and Parent/Guardian confidential and shall not disclose any personal or sensitive information to any third party without prior written consent.

Termination of Agreement:

Either party may terminate this Agreement at any time with reasonable notice. Upon termination, any outstanding payments shall be promptly made. Termination shall not affect any rights or obligations accrued prior to termination.

Liability and Indemnification:

Babysitter shall not be liable for any injury, loss, or damage except as caused by gross negligence or willful misconduct. Parent/Guardian agrees to indemnify and hold Babysitter harmless from any claims, liabilities, or expenses arising from the provision of babysitting services, except those resulting from Babysitter's gross negligence or willful misconduct.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflicts of law principles. Any disputes arising under this Agreement shall be resolved through good faith negotiation or mediation prior to resorting to litigation.

Entire Agreement; Amendments:

This Agreement constitutes the entire agreement between the parties and supersedes all prior understandings. Any amendment or modification must be in writing and signed by both parties.

Severability:

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.
