Clause 1 – Services Provided

The Service Provider agrees to perform the barbering services as requested by the Client at the agreed date, time, and location. Services include haircuts, shaves, styling, and other grooming services as mutually agreed.

Clause 2 – Appointment and Scheduling

The Client shall schedule appointments in advance. The Service Provider reserves the right to reschedule or cancel appointments with reasonable notice. The Client agrees to notify at least 24 hours in advance for cancellations or rescheduling.

Clause 3 – Payment

The Client agrees to pay the full service price as outlined above. Payment is due upon completion of the service unless otherwise agreed. Accepted payment methods include cash, credit card, or digital payment platforms.

Clause 4 – Client Conduct

The Client agrees to behave respectfully during the service. The Service Provider reserves the right to refuse service to any Client exhibiting inappropriate or unsafe behavior.

Clause 5 – Liability

The Service Provider shall perform all services to professional standards but is not liable for adverse reactions, allergies, or injuries not disclosed prior to the service. The Client agrees to inform the Service Provider of any relevant medical conditions.

Clause 6 – Cancellation and No-Show Policy

If the Client fails to attend a scheduled appointment without prior notice, the Service Provider reserves the right to charge a cancellation fee as permitted by law.

Clause 7 – Confidentiality

Any personal information shared between the Client and Service Provider shall be kept confidential and not disclosed to third parties except as required by law.

Clause 8 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, United States. Any disputes arising shall be resolved in the appropriate courts located in _____ County, _____.

Clause 9 – Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, oral or written. Amendments must be in writing and signed by both parties.

Clause 10 – Severability

If any provision of this Agreement is found invalid or unenforceable, the remaining provisions shall continue in full force and effect.

Clause 11 – Force Majeure

Neither party shall be liable for failure to perform due to causes beyond their reasonable control, including natural disasters, pandemics, or government restrictions.

Clause 12 – Indemnification

Each party agrees to indemnify and hold harmless the other from any claims arising from their own negligence or breach of this Agreement.

Clause 13 – Termination

Either party may terminate this Agreement upon written notice if the other party breaches any material term and fails to cure within a reasonable time.

Clause 14 – Notices

All notices must be in writing and delivered by hand, certified mail, overnight courier, or electronic means capable of confirming receipt, to the addresses provided.

Clause 15 – Waiver

Failure to enforce any provision shall not constitute a waiver of future enforcement.

Clause 16 – Headings

Headings are for convenience only and do not affect the interpretation of this Agreement.

Clause 17 – Counterparts

This Agreement may be executed in counterparts, each deemed an original, and all together constitute one agreement.

Clause 18 – Electronic Signatures

Electronic signatures shall be as valid and enforceable as original signatures.

Clause 19 – Client Representations

The Client represents that all information provided is truthful and that they are of legal age to enter into this Agreement.

Clause 20 – Service Provider Representations

The Service Provider represents that they are duly licensed and qualified to perform the services described herein.
