SERVICES TO BE PROVIDED:

Chef agrees to provide professional culinary services (the "Services") including but not limited to meal preparation, catering, menu planning, grocery shopping, cleaning related to the Services, and any other agreed-upon tasks as detailed in the attached Schedule A.

TERM OF AGREEMENT:

The Term of this Agreement shall commence upon execution by both parties and shall continue until completion of the Services or termination by either party in accordance with this Agreement.

COMPENSATION:

Client agrees to pay Chef the total sum as outlined in Schedule B attached hereto. Payment shall be made according to the schedule and method described therein. All payments are due without deduction or setoff.

EXPENSES:

Client shall reimburse Chef for all reasonable and pre-approved expenses incurred in the course of providing the Services, including but not limited to groceries, ingredients, supplies, and travel as specified in Schedule B.

INDEPENDENT CONTRACTOR STATUS:

Chef is engaged as an independent contractor. Nothing in this Agreement shall be construed to create an employer-employee relationship, partnership, joint venture, or agency relationship between the parties. Chef shall have no authority to bind Client.

COMPLIANCE WITH LAWS:

Chef agrees to comply with all applicable federal, state, and local laws, regulations, and ordinances related to the performance of the Services, including health and safety standards.

INSURANCE:

Chef shall maintain at their own expense all necessary insurance, including general liability and workers' compensation insurance, if applicable, during the term of this Agreement.

CONFIDENTIALITY:

Both parties agree to keep confidential all proprietary information and trade secrets learned during the performance of this Agreement and agree not to disclose such information to any third party without prior written consent.

TERMINATION:

Either party may terminate this Agreement at any time upon written notice. Client shall pay Chef for all Services rendered and expenses incurred through the date of termination.

INDEMNIFICATION:

Each party agrees to indemnify, defend, and hold harmless the other party from and against any and all claims, liabilities, damages, losses, and expenses arising out of or related to the performance or breach of this Agreement, except to the extent caused by the other party's gross negligence or willful misconduct.

LIMITATION OF LIABILITY:

In no event shall either party be liable to the other for any indirect, incidental, consequential, special, or punitive damages arising out of or related to this Agreement.

DISPUTE RESOLUTION:

Any dispute arising under or related to this Agreement shall be resolved first through good faith negotiations. If unresolved, the dispute shall be submitted to binding arbitration in accordance with the rules of the American Arbitration Association.

GOVERNING LAW:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of laws principles.

ENTIRE AGREEMENT; AMENDMENTS:

This Agreement, including all attached Schedules, constitutes the entire agreement between the parties and supersedes all prior agreements and understandings, whether written or oral. Amendments must be in writing and signed by both parties.

SEVERABILITY:

If any provision of this Agreement is found invalid or unenforceable, the remaining provisions shall remain in full force and effect.

NOTICES:

All notices under this Agreement shall be in writing and deemed given when delivered personally, sent by nationally recognized overnight courier, certified mail return receipt requested, or by electronic means with confirmation of receipt to the addresses set forth above or such other address as designated in writing.
