TERMS AND CONDITIONS:

1. SERVICES TO BE PROVIDED

The Provider agrees to provide child care services for the Child listed above, including supervision, meals, naps, educational activities, and basic health care as appropriate during the service hours agreed upon by both Parties.

2. SERVICE HOURS AND SCHEDULE

The Provider shall provide services during the agreed schedule. Any changes to the schedule must be agreed upon in writing by both Parties. Provider is not obligated to provide services on holidays unless otherwise agreed.

3. FEES AND PAYMENT

Parent/Guardian agrees to pay Provider the agreed fees for services rendered. Payment is due on the agreed dates according to the payment schedule. Late payments may incur additional charges or termination of services.

4. TERMINATION

Either Party may terminate this Agreement with written notice to the other Party at least two weeks prior to the intended termination date. Provider may terminate immediately for cause, including but not limited to non-payment or breach of terms.

5. HEALTH AND SAFETY

Parent/Guardian must provide Provider with all relevant health information about the Child, including allergies, medical conditions, medications, and emergency contacts. Provider will take reasonable steps to ensure the safety and well-being of the Child.

6. MEDICATION ADMINISTRATION

Provider will only administer medication to the Child if provided in original packaging with clear instructions and prior written consent from Parent/Guardian.

7. EMERGENCY PROCEDURES

In the event of an emergency involving the Child, Provider will attempt to contact Parent/Guardian or emergency contacts immediately and take necessary action to ensure the Child's safety, including contacting emergency medical services if warranted.

8. LIABILITY

Provider is not liable for injuries or accidents occurring outside the Provider's reasonable control, except in cases of gross negligence or willful misconduct.

9. CONFIDENTIALITY

Provider agrees to keep all personal and sensitive information about Parent/Guardian and Child confidential, except as required by law or necessary to provide the services under this Agreement.

10. BEHAVIOR AND DISCIPLINE

Provider will maintain a safe and respectful environment. Parent/Guardian agrees to inform Provider of any behavioral issues or special needs to enable appropriate care.

11. TRANSPORTATION

If transportation of the Child is part of the services, Provider will ensure that the Child is transported in a safe and lawful manner using appropriate child restraint systems.

12. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the State specified by the Parties, without regard to conflict of law principles.

13. AMENDMENTS

Any modifications or amendments to this Agreement must be made in writing and signed by both Parties.

14. ENTIRE AGREEMENT

This document constitutes the entire Agreement between the Parties and supersedes all prior oral or written agreements.

15. FORCE MAJEURE

Neither Party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including natural disasters, acts of government, or other emergencies.

16. NON-WAIVER

Failure by either Party to enforce any provision shall not be construed as waiver of any subsequent breach.

17. SEVERABILITY

If any provision is found invalid or unenforceable, the remainder shall remain in full force and effect.

18. SIGNATURES

Both Parties acknowledge that they have read, understood, and agree to the terms set forth in this Agreement.
