## Division of Property and Debt:

The parties agree upon the equitable division of community property, separate property, debts, and liabilities as follows. Each party shall retain sole ownership of their separate property. Community property shall be divided as set forth in the attached Schedule A. All debts and liabilities incurred during the marriage shall be allocated as set forth in Schedule B. Both parties warrant full and accurate disclosure.

## Spousal Support and Maintenance:

Spousal support, if any, shall be paid by the party as agreed herein and detailed in Schedule C. Support obligations and duration are subject to applicable state laws. Both parties waive claims for future support except as stated.

## Child Custody and Support:

Custody of minor children, visitation schedules, and child support obligations shall be as detailed in Schedule D. These arrangements are made in the best interest of the children and comply with applicable state and federal laws.

## Health Insurance and Medical Expenses:

The parties agree to maintain adequate health insurance coverage for the minor children and make reasonable arrangements for uninsured medical, dental, and educational expenses as outlined in Schedule E.

**Taxes:**

The parties shall cooperate in filing all necessary federal, state, and local tax returns, and allocate any tax refunds, liabilities, or credits in accordance with the division of property and custody arrangements.

**Release of Claims:**

Except as specifically provided herein, each party releases and waives any and all claims against the other arising out of the marriage, including claims for property, support, or other obligations, except those arising under this Agreement or required by law.

**Legal Representation and Voluntariness:**

Each party acknowledges that they have had the opportunity to seek independent legal counsel, fully understand the terms herein, and enter into this Agreement voluntarily, without duress, coercion, or undue influence.

**Governing Law and Enforcement:**

This Agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_. The parties consent to the exclusive jurisdiction and venue of the courts located therein for enforcement or interpretation of this Agreement.

**Modification and Entire Agreement:**

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, negotiations, or understandings, whether oral or written. Any modification must be in writing and signed by both parties.

**Severability:**

If any provision is found to be unenforceable or invalid, the remainder of the Agreement shall remain in full force and effect and the invalid provision shall be replaced by a valid provision that most closely reflects the parties' intent.

**Execution and Counterparts:**

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one instrument. Signatures transmitted electronically or by facsimile shall be deemed original signatures for all purposes.
