## **SERVICES TO BE PROVIDED:**

Walker agrees to provide dog walking services including but not limited to: daily walks, feeding, administering medication as instructed by Owner, and providing companionship during each visit. Services will be provided at agreed-upon times and locations as specified by the Owner. Walker shall exercise reasonable care and diligence in handling the dog.

## **PAYMENT TERMS:**

Owner agrees to pay the Walker the sum of \$\_\_\_\_\_ per walk or as otherwise agreed. Payments shall be made promptly upon receipt of invoice or according to the agreed schedule. Late payments may be subject to interest or late fees as permitted by law.

## **TERM AND TERMINATION:**

This Agreement shall commence on the effective date and continue until terminated by either party with at least 7 days written notice. Either party may terminate immediately for cause, including but not limited to breach of this Agreement or if the Walker believes the dog is at risk of harm.

## **OWNER'S WARRANTIES AND REPRESENTATIONS:**

Owner represents and warrants that the dog is in good health, has all required vaccinations, and does not pose a threat to others. Owner has disclosed all known behavioral or medical issues to the Walker. Owner agrees to provide accurate

and complete information relevant to the care of the dog.

**WALKER'S OBLIGATIONS AND LIABILITY:**

Walker agrees to exercise reasonable care, skill, and diligence in the performance of services. Walker shall comply with all applicable laws and regulations. Walker shall not be liable for injury, loss, or damage caused by the dog or resulting from circumstances beyond Walker's control unless due to Walker's gross negligence or willful misconduct.

**INDEMNIFICATION:**

Owner agrees to indemnify and hold harmless the Walker from any claims, damages, losses, or expenses arising out of or related to the Owner's failure to disclose relevant information or resulting from the dog's behavior.

**EMERGENCY AUTHORIZATION:**

Owner authorizes Walker to seek veterinary care for the dog in case of emergency and agrees to be responsible for all related costs.

**GOVERNING LAW AND DISPUTE RESOLUTION:**

This Agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_.
