## Recitals:

WHEREAS, the parties are members of the same family and desire to enter into this Agreement to establish their mutual rights, duties, and responsibilities; and WHEREAS, the parties intend this Agreement to be legally binding and enforceable under the laws of the United States of America.

### 1. Purpose
