Clause 1 – Agreement to Participate

Participant agrees to enter the Fantasy Football League for the specified season and to abide by all league rules, bylaws, and decisions made by the League Commissioner and governing body.

Clause 2 – Entry Fee and Payments

Participant agrees to pay the entry fee as stated above by the deadline established by the League. Failure to pay the entry fee timely may result in disqualification or restrictions on participation.

Clause 3 – Team Management

Participant is responsible for managing their own Fantasy Football team, including roster selection, trades, and daily lineup decisions. Delegation of team management is permissible if communicated to the League Commissioner.

Clause 4 – Conduct and Sportsmanship

Participant agrees to conduct themselves in a manner consistent with good sportsmanship and respect toward other participants. Harassment, cheating, or any form of misconduct is grounds for penalties including suspension or expulsion from the League.

Clause 5 – League Rules and Amendments

All Participants acknowledge receipt of the League Rules and agree that such rules may be amended by the League Commissioner with reasonable notice. Continued participation constitutes acceptance of any amendments.

Clause 6 – Prizes and Payouts

Prizes will be awarded as specified in the League Rules. The League is not responsible for any tax liabilities arising from prize winnings. Participants are solely responsible for compliance with applicable laws.

Clause 7 – Liability and Indemnification

Participant releases and holds harmless the League, its officers, commissioners, agents, and sponsors from any claims, damages, or losses arising from participation in the League, except for damages caused by willful misconduct or gross negligence.

Clause 8 – Termination and Removal

The League reserves the right to remove or suspend any Participant who violates the League Rules or this Agreement. Termination of participation does not relieve the Participant of any outstanding fees or obligations.

Clause 9 – Data and Privacy

Participant consents to the collection, use, and disclosure of personal information as necessary for League administration, communication, and promotion, consistent with applicable privacy laws.

Clause 10 – Dispute Resolution

Any disputes arising out of or relating to this Agreement or the League shall be resolved first through informal negotiation. If unsuccessful, disputes shall be resolved by binding arbitration in accordance with the rules of the American Arbitration Association.

Clause 11 – Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of law principles. Venue for any legal proceedings shall be the state or federal courts located in _____ County, _____.

Clause 12 – Entire Agreement

This Agreement, together with the League Rules, represents the entire agreement between the Participant and the League with respect to Fantasy Football participation and supersedes all prior agreements or understandings.

Clause 13 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

Clause 14 – Waiver

Failure by either party to enforce any provision of this Agreement shall not constitute a waiver of that provision or any other.

Clause 15 – Electronic Communications

Participant agrees that all communications, records, and signatures may be electronic and that electronic delivery is sufficient for all purposes.

Clause 16 – Participant Representations

Participant represents that they are at least 18 years of age, have legal capacity to enter this Agreement, and will comply with all applicable laws and league rules.

Clause 17 – No Gambling

Participant acknowledges that Fantasy Football is a game of skill and not gambling, and that no real money is wagered or won except the stated entry fee and prize pool.

Clause 18 – Force Majeure

The League shall not be liable for failure or delay in performance due to causes beyond its reasonable control, including but not limited to acts of God, war, terrorism, pandemics, or governmental restrictions.

Clause 19 – Assignment

Participant may not assign or transfer their rights or obligations under this Agreement without prior written consent of the League.

Clause 20 – Signatures and Counterparts

This Agreement may be executed in counterparts and by electronic signature, each of which shall be deemed an original and all of which constitute one and the same instrument.
