Clause 1 – Engagement and Services

Producer hereby engages Talent to perform services as an actor/performer in the production titled above (the “Production”), and Talent accepts such engagement, subject to the terms and conditions of this Agreement.

Clause 2 – Term; Scheduling

Talent agrees to be available for the shooting schedule and any other dates reasonably required by Producer. Producer shall provide Talent with reasonable advance notice of all scheduled days and locations.

Clause 3 – Compensation

Producer agrees to pay Talent the total compensation stated above, payable according to the agreed payment schedule. Talent acknowledges that no additional compensation will be due unless agreed in writing.

Clause 4 – Rights Granted

Talent grants Producer and its licensees the exclusive rights to use Talent’s name, likeness, voice, and performance as captured in the Production in all media now known or hereafter devised, worldwide, in perpetuity.

Clause 5 – Representations and Warranties

Talent represents and warrants that Talent has the full legal right and authority to enter into and perform this Agreement; that Talent is not subject to any restriction which would interfere with the services; and that all services will be original and not infringe upon any third-party rights.

Clause 6 – Confidentiality

Talent agrees to keep confidential all non-public information concerning the Production and Producer, including scripts, storylines, and production details, and shall not disclose such information without prior written consent.

Clause 7 – Work Product

All performances, materials, and deliverables produced by Talent under this Agreement shall be considered work made for hire and shall be the sole property of Producer.

Clause 8 – Termination

Either party may terminate this Agreement for cause upon written notice. Upon termination, Talent shall be compensated for all services rendered prior to termination.

Clause 9 – Indemnification

Talent agrees to indemnify and hold Producer harmless from any claims arising from Talent’s breach of representations or warranties, or from Talent’s negligence or willful misconduct.

Clause 10 – Compliance with Laws

Both parties agree to comply with all applicable laws, rules, and regulations in connection with their performance under this Agreement.

Clause 11 – Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. The parties submit to the exclusive jurisdiction of the state and federal courts located in _____ County, _____ for any disputes.

Clause 12 – Entire Agreement

This Agreement contains the entire understanding of the parties and supersedes all prior agreements or understandings relating to the subject matter herein.

Clause 13 – Amendments

Any amendments or modifications to this Agreement must be in writing and signed by both parties.

Clause 14 – Notices

All notices under this Agreement shall be in writing and sent to the addresses set forth above or such other addresses as the parties may designate in writing.

Clause 15 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remainder shall remain in full force and effect.

Clause 16 – No Waiver

Failure to enforce any provision of this Agreement shall not constitute a waiver of that or any other provision.

Clause 17 – Independent Contractor

Talent is an independent contractor and nothing in this Agreement shall be construed to create an employer-employee relationship.

Clause 18 – Force Majeure

Neither party shall be liable for failure to perform due to causes beyond their reasonable control, including acts of God, war, or government action.

Clause 19 – Counterparts and Electronic Signatures

This Agreement may be executed in counterparts, including via electronic signature, each of which shall be deemed an original.

Clause 20 – Signatures

The parties have executed this Agreement as of the effective date agreed between them.
