Player Duties and Obligations:

The Player agrees to render their professional football services exclusively to the Club during the Contract Term. The Player shall maintain physical fitness, comply with the Club's training schedules, participate in matches and events as directed, and abide by all rules, regulations, and codes of conduct established by the Club and the governing football associations.

Compensation and Benefits:

The Club agrees to pay the Player a total gross compensation of _____ USD for the Contract Term, payable in monthly installments or as otherwise agreed. The Player shall also be entitled to performance bonuses, allowances, and benefits as specified in the Club's policies or additional written agreements. All payments are subject to applicable tax withholdings and deductions as required by law.

Insurance and Medical Care:

The Club shall provide health and injury insurance coverage to the Player during the Contract Term. The Player agrees to undergo medical examinations and adhere to medical advice as required. The Club is responsible for reasonable medical expenses arising from injuries sustained in the course of official football activities.

Termination and Suspension:

This Contract may be terminated by either party upon material breach, failure to perform obligations, mutual agreement, or for cause as defined by applicable law and football governing bodies' regulations. The Club may suspend the Player for disciplinary reasons following due process. Termination shall be effective upon written notice.

Intellectual Property and Image Rights:

The Player grants the Club the right to use their name, image, and likeness for promotional, marketing, and commercial purposes during the Contract Term. All intellectual property created in connection with the Player's services for the Club shall belong to the Club unless otherwise agreed in writing.

Confidentiality:

The Player agrees to maintain the confidentiality of all proprietary information, trade secrets, and internal matters of the Club, both during and after the Contract Term. Disclosure of confidential information without prior written consent is prohibited.

Governing Law and Dispute Resolution:

This Contract shall be governed by and construed in accordance with the laws of the United States and the State of _____. Any disputes arising under or relating to this Contract shall be resolved by binding arbitration or in the courts located in _____ County, _____, as agreed by the parties, waiving any right to a jury trial to the maximum extent permitted by law.

Entire Agreement and Amendments:

This Contract, including any attached schedules or exhibits, constitutes the entire agreement between the Club and the Player with respect to the subject matter herein. No amendment or modification shall be effective unless in writing and signed by both parties.

Force Majeure:

Neither party shall be liable for any failure or delay in performance caused by events beyond their reasonable control, including but not limited to natural disasters, acts of government, war, strikes, or pandemics. Obligations shall be suspended during such events and resumed promptly thereafter.

Player Representations and Warranties:

The Player represents and warrants that they have the legal right and capacity to enter into this Contract, that there are no existing agreements or obligations that conflict with this engagement, and that all information provided to the Club is true and accurate.

Club Representations and Warranties:

The Club represents and warrants that it is duly organized and authorized to enter into this Contract, that it has the financial ability to fulfill its obligations, and that this Contract does not violate any applicable laws or regulations.

Severability:

If any provision of this Contract is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect to the maximum extent permitted by law.

Notices:

All notices required or permitted under this Contract shall be in writing and deemed delivered when hand-delivered, sent by certified mail, nationally recognized overnight courier, or by electronic means with confirmation, to the parties at their respective addresses specified herein or as updated in writing.
