Recitals:

Terms and Conditions:

1. Purpose and Scope

8. Governing Law

10. Entire Agreement

This Agreement constitutes the entire understanding between the Parties relating to the subject matter herein and supersedes all prior agreements, oral or written.

11. Amendments

Any amendments or modifications to this Agreement must be in writing and signed by both Parties.

12. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue to be valid and enforceable.

13. No Partnership or Agency

Nothing contained in this Agreement shall be deemed to create a partnership, joint venture, or agency relationship between the Parties.

14. No Consideration

The Parties acknowledge that this Agreement is entered into voluntarily and without any monetary or other consideration.

15. Representations and Warranties

Each Party represents and warrants that they have full capacity and authority to enter into this Agreement.

16. Privacy and Data Protection

The Parties agree to comply with all applicable data protection laws concerning any personal data exchanged in connection with this Agreement.

17. Waiver

No waiver of any breach or default under this Agreement shall be deemed a waiver of any preceding or subsequent breach or default.

18. Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which constitute one and the same instrument.

19. Notices

All notices under this Agreement shall be in writing and delivered by hand, certified mail, email with confirmation, or nationally recognized overnight courier to the addresses provided herein or as otherwise designated.

20. Signatures

This Agreement shall be signed by both Parties to evidence their understanding and acceptance of its terms.
