Purpose of Contract:

This Contract sets forth the terms and conditions agreed upon by the undersigned students who form a group ("Group") for the purpose of collaborating on academic projects, assignments, or any other group-related activities as part of their studies in the Institution/Organization identified above. All members agree to participate in good faith, contribute equitably, and adhere to all applicable rules and guidelines set forth by the Institution and this Contract.

Group Member Responsibilities:

1. Each member shall contribute their best efforts and skills towards the successful completion of group assignments and projects. 2. Members agree to attend all scheduled meetings and communicate promptly with the group. 3. Responsibilities for specific tasks shall be assigned cooperatively and fulfilled in a timely manner. 4. Members shall respect each other's ideas, contributions, and confidentiality of shared information. 5. Any conflicts or issues shall be addressed promptly and respectfully among members, and escalated to the course instructor if unresolved.

Attendance and Participation:

All group members are expected to participate actively in group activities. Absences or lack of participation must be communicated in advance to the group leader and group members. Repeated unexcused absences may affect the group's performance and could result in consequences as determined by the Institution.

Academic Integrity and Plagiarism:

Each group member shall uphold the highest standards of academic integrity. All submitted work must be the product of the group's own efforts, and proper citations must be included where applicable. Any form of plagiarism or academic dishonesty by any member may result in disciplinary action against the group and/or the individual in accordance with the Institution's policies.

Conflict Resolution:

In the event of disagreements or conflicts among group members, the group agrees to attempt resolution through open communication and mediation. If a resolution cannot be reached, members may seek assistance from the course

instructor or designated Institutional authority. All parties agree to cooperate in good faith during any resolution process.

Withdrawal or Removal of Group Members:

Any member who wishes to withdraw from the group shall notify the group leader and members promptly. The group reserves the right to remove any member whose actions are detrimental to the group's objectives or violate the terms of this Contract, subject to approval by the majority of remaining members and notification to the course instructor.

Liability and Indemnification:

Each member shall be individually responsible for their own actions and any damages resulting therefrom. The group as a whole agrees to indemnify and hold harmless each member from claims, losses, or damages arising from group activities, except in cases of willful misconduct or gross negligence by the indemnified member.

Governing Law and Jurisdiction:

This Contract shall be governed by and construed in accordance with the laws of the United States and the applicable State law governing contracts for educational purposes. Any disputes arising out of or relating to this Contract shall be subject to the exclusive jurisdiction of the state or federal courts located within the State of the Institution.

Entire Agreement; Amendments:

This Contract constitutes the entire agreement among the group members with respect to the subject matter hereof and supersedes all prior understandings, agreements, or representations. Any amendments or modifications to this Contract must be in writing and signed by all group members.
