Warranty:

Service Provider warrants that all workmanship shall be performed in a professional and workmanlike manner and materials shall be as specified. Warranty period is one (1) year from the date of completion. This warranty does not cover damage resulting from misuse, neglect, accidents, or acts of nature.

Liability and Insurance:

Service Provider agrees to maintain general liability insurance covering claims arising out of the performance of this Agreement. Service Provider is not liable for any indirect, incidental, or consequential damages. Customer shall indemnify and hold Service Provider harmless from any claims arising from Customer's negligence or failure to maintain the property.

Compliance with Law:

Service Provider shall perform all services in compliance with applicable federal, state, and local laws, codes, and regulations.

Dispute Resolution:

Any dispute arising out of or relating to this Agreement shall be resolved first through good faith negotiation between the parties. If unresolved, disputes shall be subject to binding arbitration in the state where the Services are performed, in accordance with the rules of the American Arbitration Association.

Entire Agreement and Amendments:

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, representations, and agreements. No amendment shall be effective unless in writing and signed by both parties.

Severability:

If any provision of this Agreement is declared invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflict of laws principles. The parties consent to the exclusive jurisdiction of the state and federal courts located in _____ County, _____ for any legal actions arising hereunder.
