Stylist is an independent contractor and not an employee of the Salon.

Stylist is solely responsible for all taxes, insurance, and licenses required.

Duties and Responsibilities:

Stylist agrees to provide professional hair care and related services at the Salon premises during agreed hours. Stylist shall conduct themselves in a professional manner and comply with all applicable laws, regulations, and Salon policies.

Supplies and Equipment:

Stylist is responsible for providing their own tools and supplies necessary to perform services unless otherwise agreed. Salon may provide shared equipment and supplies at its discretion.

Term and Termination:

This Agreement shall continue until terminated by either party upon written notice. Either party may terminate at any time with or without cause. Upon termination, Stylist shall cease all use of Salon facilities and remove personal property.

Confidentiality:

Stylist agrees to keep all Salon business information, client lists, and trade secrets confidential both during and after the term of this Agreement.

Non-Compete and Non-Solicitation:

During the term and for one year following termination, Stylist shall not solicit Salon clients for competing services nor engage in a competing business within a 10-mile radius of the Salon location.

Indemnification and Liability:

Stylist agrees to indemnify and hold harmless the Salon, its owners, and employees from any claims, damages, or liabilities arising from Stylist's services, negligence, or breach of this Agreement.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. Any disputes arising shall be resolved through binding arbitration in accordance with the rules of the American Arbitration Association.

Entire Agreement and Amendments:

This Agreement contains the entire understanding between the parties and supersedes all prior agreements, oral or written. No amendment shall be valid unless in writing and signed by both parties.

Severability:

If any provision of this Agreement is found invalid or unenforceable, the remaining provisions shall continue in full force and effect.
