Horse Care and Liability:

Client represents and warrants that the horse is in good health and free from any contagious or dangerous condition. Trainer shall exercise reasonable care in handling and training the horse but shall not be liable for injury, death, or loss resulting from causes beyond Trainer's control, including but not limited to acts of God, theft, or negligence of third parties. Client shall maintain appropriate insurance coverage for the horse during the term of this Agreement.

Termination:

Either party may terminate this Agreement by providing written notice to the other party. Upon termination, Client shall pay Trainer for all training services rendered and expenses incurred through the date of termination. Trainer shall return the horse to Client within a reasonable time after termination.

Dispute Resolution:

Any dispute arising out of or relating to this Agreement shall be resolved first through good faith negotiation between the parties. If unresolved, disputes shall be submitted to mediation before a mutually agreed mediator. If mediation fails, disputes shall be resolved by binding arbitration administered in accordance with the rules of the American Arbitration Association. Judgment upon the award rendered by the arbitrator may be entered in any court having jurisdiction thereof.

Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflict

Miscellaneous:

- This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, whether written or oral.
- No modification or waiver of any provision of this Agreement shall be effective unless in a writing signed by both parties.
- If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.
- Neither party may assign this Agreement without the prior written consent of the other party.
- All notices required or permitted under this Agreement shall be in writing and delivered personally, by certified mail, or by national overnight courier.
