neglect as required by law.

Liability and Indemnification:

1. Limitation of Liability: Provider shall not be liable for injuries or illnesses except those caused by Provider's negligence or willful misconduct. 2. Indemnification: Parent agrees to indemnify and hold Provider harmless from any claims arising out of the Child's actions. 3. Insurance: Provider maintains liability insurance as required by state law.
