Decorator shall provide interior decorating services including consultation, design, selection, and procurement of furniture, fixtures, finishes, and accessories as agreed between the parties. The scope excludes structural modifications or alterations unless separately agreed in writing.

Term and Termination:

This Agreement commences upon execution and continues until completion of services unless terminated earlier by either party providing written notice. Either party may terminate this Agreement for cause upon material breach by the other party, subject to a 14-day cure period following written notice. Upon termination, Client shall pay for all services performed and expenses incurred through the termination date.

Responsibilities and Obligations:

Decorator agrees to perform services with professional skill, care, and diligence consistent with industry standards. Client shall provide access to premises, timely decisions, and necessary approvals to facilitate services. Decorator is not responsible for latent defects or conditions not reasonably discoverable.

Intellectual Property and Use of Work Product:

All work product created by Decorator under this Agreement, including designs, drawings, and specifications, remain the property of Decorator until full payment is received. Upon full payment, Client shall have a non-exclusive license to use the work product for the specified project only. Decorator may retain copies for record-keeping, marketing, and

portfolio purposes unless otherwise agreed in writing.

Confidentiality:

Each party agrees to keep confidential all proprietary, technical, financial, and business information disclosed during the course of this Agreement. Confidential information shall not be disclosed to third parties except as required by law or with prior written consent.

Limitation of Liability:

Decorator's total liability arising out of or related to this Agreement shall not exceed the total fees paid by Client. In no event shall Decorator be liable for incidental, consequential, or punitive damages, including but not limited to loss of profit or business interruption.

Indemnification:

Client agrees to indemnify, defend, and hold harmless Decorator and its employees, agents, and subcontractors from any claims, damages, liabilities, costs, or expenses arising from Client's negligence, misuse of work product, or breach of this Agreement.

Force Majeure:

Neither party shall be liable for any failure or delay in performance due to causes beyond their reasonable control, including acts of God, war, terrorism, labor disputes, governmental actions, or natural disasters. Affected party shall notify the other promptly and resume performance as soon as practicable.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflict of laws principles. The parties agree to submit to the exclusive jurisdiction of the state and federal courts located within _____ County, _____. The parties waive any right to a trial by jury in any dispute arising under this Agreement to the maximum extent permitted by law.

Entire Agreement and Amendments:

Any amendments or modifications must be in writing and signed by authorized representatives of both parties.

Severability:

If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect to the fullest extent permitted by law.

Waiver:

Failure or delay by either party to enforce any provision of this Agreement shall not constitute a waiver of that provision or any other provision.

Notices:

All notices under this Agreement shall be in writing and delivered personally, by nationally recognized overnight courier, certified mail (return receipt requested), or by email with confirmation of receipt, to the addresses listed above or as otherwise designated in writing.
