Clause 1 – Services Provided

Service Provider agrees to perform lawn mowing and related landscaping services described in this Agreement at the Client's property. Services will be performed in a professional and workmanlike manner consistent with industry standards.

Clause 2 – Term and Termination

This Agreement shall continue until either party terminates by providing written notice at least seven (7) days in advance. Termination does not relieve Client of payment obligations for services rendered through the termination date.

Clause 3 – Payment

Client agrees to pay Service Provider the agreed rate per service as specified above. Payments shall be made via the agreed method promptly according to the payment terms. Late payments may incur interest as permitted by law.

Clause 4 – Equipment and Materials

Service Provider will supply all equipment, tools, and materials necessary to perform the services, unless otherwise agreed in writing.

Clause 5 – Access to Property

Client shall provide reasonable access to the property for Service Provider's personnel and equipment during agreed

service hours.

Clause 6 – Liability and Insurance

Service Provider shall maintain appropriate liability insurance. Service Provider is not responsible for damage caused by factors beyond reasonable control, including but not limited to weather, underground utilities, or client-owned equipment.

Clause 7 – Indemnification

Client agrees to indemnify and hold Service Provider harmless from any claims, damages, losses, or expenses arising out of Client's negligence or failure to disclose relevant property conditions.

Clause 8 – Independent Contractor

Service Provider performs services as an independent contractor and not as an employee or agent of Client.

Clause 9 – Warranties and Disclaimer

Service Provider warrants that services will be performed in a competent manner. Except as expressly stated, no other warranties, express or implied, are made, including warranties of merchantability or fitness for a particular purpose.

Clause 10 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United States and the State where the services are performed, without regard to conflict of law principles.

Clause 11 – Dispute Resolution

Any disputes arising under this Agreement shall first be attempted to be resolved through good faith negotiation. If unresolved, parties may seek mediation or binding arbitration in accordance with the rules of a mutually agreed arbitration service.

Clause 12 – Notices

All notices required or permitted under this Agreement shall be in writing and delivered personally, by certified mail, or by nationally recognized overnight courier to the addresses listed herein.

Clause 13 – Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior communications, representations, or agreements, whether oral or written.

Clause 14 – Amendments

Any amendments or modifications to this Agreement must be in writing and signed by both parties to be effective.

Clause 15 – Severability

If any provision of this Agreement is found invalid or unenforceable, the remainder shall continue in full force and effect.

Clause 16 – Force Majeure

Neither party shall be liable for delays or failure to perform due to causes beyond reasonable control, including acts of God, natural disasters, or governmental actions.

Clause 17 – Confidentiality

Both parties agree to keep confidential any proprietary information exchanged in connection with this Agreement, except as required by law.

Clause 18 – Safety

Service Provider shall conduct operations in compliance with all applicable safety laws and regulations.

Clause 19 – Client Responsibilities

Client agrees to remove obstacles and hazards that could interfere with service or cause damage to equipment.

Clause 20 – Signatures

This Agreement may be executed in counterparts and electronically. Both parties acknowledge that signatures indicate acceptance and agreement to the terms herein.
