Services Description:

The Coach agrees to provide life coaching services to the Client as agreed upon by both parties. Services may include, but are not limited to, goal setting, personal development strategies, motivation, and accountability coaching tailored to the Client's individual needs and objectives.

Term and Termination:

The Client is responsible for their own actions and decisions.

Limitation of Liability:

To the fullest extent permitted by law, the Coach shall not be liable for any indirect, incidental, special, consequential, or punitive damages arising out of or related to this Agreement, even if advised of the possibility of such damages.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. Any disputes arising from this Agreement shall be resolved through mediation or binding arbitration in the jurisdiction agreed upon by the parties.

Entire Agreement:
