The term of this Agreement shall commence upon mutual execution and continue until the completion of services unless earlier terminated. Either party may terminate this Agreement upon written notice if the other party materially breaches any term and fails to cure within a reasonable period.

Intellectual Property:

All copyright and intellectual property rights in the deliverables shall be transferred to Client upon full payment unless otherwise agreed in writing. Service Provider retains the right to use work for promotional purposes unless Client objects in writing.

Confidentiality:

Each party agrees to maintain the confidentiality of all proprietary or confidential information received from the other party during the term of this Agreement and not to disclose such information except as required by law or authorized in writing.

Representations and Warranties:

Each party represents and warrants that it has the full right and authority to enter into this Agreement and perform its

obligations. Service Provider warrants that the services will be performed in a professional and workmanlike manner.

Indemnification:

Each party agrees to indemnify, defend, and hold harmless the other party from any claims, damages, liabilities, costs, and expenses arising from breach of this Agreement or negligence.

Limitation of Liability:

Neither party shall be liable for indirect, incidental, consequential, or punitive damages arising from this Agreement. The total liability of either party shall not exceed the total fees paid under this Agreement.

Independent Contractor:

Service Provider is an independent contractor and nothing in this Agreement creates an employer-employee, partnership, or joint venture relationship.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of laws principles. The parties consent to exclusive jurisdiction and venue in the state or federal courts located in _____ County, _____.

Notices:

All notices under this Agreement shall be in writing and delivered by hand, certified mail, overnight courier, or electronic transmission with confirmation, to the addresses set forth above or such other addresses as designated by written notice.

Entire Agreement and Amendments:

This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements and understandings. Any amendments must be in writing and signed by both parties.

Severability:

No waiver of any breach or right under this Agreement shall be effective unless in writing and signed by the waiving party. No waiver shall be a waiver of any subsequent breach or right.

Force Majeure:

Neither party shall be liable for failure or delay in performance due to causes beyond reasonable control including acts of God, war, government actions, strikes, or natural disasters.
