## **Purpose:**

- Act respectfully and responsibly at all times.
- Seek help from teachers or counselors if needed.
- Participate in developing goals for improving behavior.
- Communicate any challenges or concerns honestly.

## **Parent/Guardian Responsibilities:**

- Support the school in enforcing this contract.
- Discuss the importance of positive behavior with the student.
- Communicate with school staff regarding behavioral concerns.
- Encourage the student to meet behavior and academic goals.
- Attend meetings and conferences as needed.

## **Teacher/Administrator Responsibilities:**

- Provide clear expectations and consistent enforcement.
- Support the student in meeting behavioral goals.

- Communicate regularly with parents/guardians and student.
- Offer resources and interventions as needed.
- Maintain a safe and supportive learning environment.

**Duration and Review:**

This contract is effective upon signing by all parties and remains in effect for the remainder of the current school year, subject to periodic review and amendments as necessary to support the student's success.
