Contract Terms and Conditions:

1. Appointment and Authority

The Model hereby appoints the Agency as her exclusive representative for modeling assignments during the term of this Agreement. The Agency shall have the exclusive right to procure engagements and negotiate contracts on behalf of the Model.

2. Term

This Agreement shall commence upon signature and continue until terminated by either party with thirty (30) calendar days written notice.

3. Compensation and Commission

The Model agrees to pay the Agency a commission of twenty percent (20%) of all gross earnings from assignments secured by the Agency, payable within seven (7) days of receipt.

4. Duties of the Agency

The Agency shall use reasonable efforts to obtain modeling assignments and will act in the Model's best interests. The Agency is authorized to negotiate terms and conditions on behalf of the Model.

5. Duties of the Model

The Model agrees to maintain professional conduct, attend assignments punctually, and provide truthful information. The Model shall not engage other agencies during the term without written consent.

6. Expenses

Unless otherwise agreed in writing, the Model shall bear all personal expenses including travel, lodging, and wardrobe costs.

7. Exclusivity

During the term, the Model shall not procure modeling services independently or through other agencies without prior written approval from the Agency.

8. Intellectual Property and Usage Rights

The Model grants the Agency and clients the right to use photographs, videos, and other media for promotional and commercial purposes in perpetuity.

9. Confidentiality

Both parties agree to keep confidential all proprietary information obtained during the course of this Agreement.

10. Termination

Either party may terminate this Agreement with thirty (30) calendar days written notice. Termination shall not affect commissions due for assignments secured prior to termination.

11. Independent Contractor Status

The Model is an independent contractor and not an employee. The Agency shall not be responsible for withholding taxes or providing employment benefits.

12. Indemnification

The Model agrees to indemnify and hold harmless the Agency from any claims, damages, or liabilities arising from the Model's conduct or breach of this Agreement.

13. Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____ without regard to conflict-of-law principles. The parties consent to exclusive jurisdiction in the state and federal courts located in _____ County, _____.

14. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, oral or written.

15. Amendments

Any amendments or modifications must be in writing and signed by both parties.

16. Severability

If any provision is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

17. Force Majeure

Neither party shall be liable for failure to perform due to causes beyond reasonable control, including acts of God, government actions, or labor disputes.

18. Non-Waiver

Failure to enforce any provision shall not constitute a waiver of that provision or any other.

19. Notices

All notices shall be in writing and deemed given upon delivery by hand, certified mail, or recognized overnight courier to the addresses set forth herein.

20. Signatures and Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which constitute one instrument.
