1. Services Provided

Personal Chef agrees to prepare, cook, and serve meals as detailed in this Agreement for the Client at the Service Location(s) specified. The Chef shall provide the necessary ingredients, kitchen equipment, and utensils unless otherwise agreed.

2. Term and Termination

This Agreement shall commence on the date of execution and shall continue until terminated by either party with at least seven (7) days' written notice. Termination shall not relieve Client of payment obligations for services rendered.

3. Client Responsibilities

Client shall provide a suitable kitchen environment and access to necessary appliances. Client agrees to inform the Chef of any allergies, dietary restrictions, or preferences prior to service.

4. Payment and Fees

Client agrees to pay the agreed fees in accordance with the Payment Schedule. Late payments may incur interest or service suspension. Additional services not specified herein will be billed separately.

5. Cancellation and Rescheduling

Client may cancel or reschedule services with at least 48 hours' notice without penalty. Cancellations with less than 48 hours' notice may incur a cancellation fee equal to 50% of the scheduled service fee.

6. Health and Safety

Chef agrees to comply with all applicable health, safety, and sanitation regulations. Client agrees to inform Chef of any hazards or unsafe conditions at the service location.

7. Liability and Indemnification

Chef shall maintain appropriate insurance coverage. Client agrees to indemnify and hold harmless the Chef from any claims arising from Client's negligence or failure to disclose relevant health information.

8. Confidentiality

Both parties agree to keep confidential any proprietary or personal information disclosed during the term of this Agreement.

9. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United States and the State in which the services are performed, without regard to conflict of law principles.

10. Dispute Resolution

In the event of any dispute arising under this Agreement, the parties agree to first attempt mediation before pursuing any other legal remedies.

11. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior negotiations or agreements, whether written or oral.

12. Amendments

Any amendments to this Agreement must be in writing and signed by both parties.

13. Independent Contractor

Chef is an independent contractor and not an employee of Client. Nothing herein shall be construed to create any partnership, joint venture, or employer-employee relationship.

14. Force Majeure

Neither party shall be liable for delays or failure to perform due to events beyond their reasonable control, including natural disasters, acts of government, or other force majeure events.

15. Notices

All notices required or permitted under this Agreement shall be in writing and sent to the addresses listed above by hand delivery, certified mail, or electronic mail with confirmation.

16. Severability

If any provision of this Agreement is deemed invalid or unenforceable, the remaining provisions shall remain in full force and effect.

17. Waiver

Failure to enforce any provision of this Agreement shall not constitute a waiver of that provision or any other provision.

18. Assignment

Neither party may assign or transfer any rights or obligations under this Agreement without prior written consent of the other party.

19. Headings

Headings are for convenience only and shall not affect the interpretation of this Agreement.

20. Signatures

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one instrument.
