### 1. Rental Period and Delivery

The Rental Company agrees to provide the photo booth and related equipment to Client for the agreed rental period and event location. Delivery, setup, and removal times are included within the rental duration unless otherwise specified. Client shall ensure unobstructed access to the event location for delivery and setup.

### 2. Client Obligations

Client shall provide a suitable location for the photo booth with access to electricity and shelter from weather conditions if required. Client is responsible for the conduct of event guests and agrees to use the photo booth equipment in a safe manner. Any damage to equipment caused by Client, guests, or third parties shall be Client's responsibility.

### 3. Equipment Condition and Use

Rental Company warrants that all equipment is in good working order at time of delivery. Client acknowledges that photo booth use involves inherent risks and agrees to operate the equipment responsibly. Rental Company shall not be

liable for any loss or damage resulting from misuse or malfunction during the rental period.

#### **4. Payments and Refunds**

A non-refundable deposit as specified is required to secure the rental date. The balance is due prior to or at event setup, unless otherwise agreed. No refunds shall be made for early termination or no-shows by Client. Late payments may incur additional fees or termination of this Agreement.

#### **5. Cancellation Policy**

Client may cancel this Agreement by written notice. Deposits are non-refundable. Cancellations made less than 14 days prior to the event may be subject to additional fees equal to the rental fee. Rental Company reserves the right to cancel the Agreement due to unforeseen circumstances, providing full refund to Client.

#### **6. Indemnification and Liability**

Client agrees to indemnify, defend, and hold harmless Rental Company, its employees, and agents from any claims, damages, or losses arising out of Client's use of the photo booth equipment, except for damages caused by gross negligence or willful misconduct of Rental Company.

#### **7. Force Majeure**

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, governmental action, fire, flood, or other natural disasters.

#### **8. Governing Law and Venue**

This Agreement shall be governed by the laws of the United States and the State where the rental company is located, without regard to conflict of law principles. The parties consent to exclusive jurisdiction and venue in the appropriate state or federal courts located therein.

#### **9. Entire Agreement**

This Agreement constitutes the entire understanding between the parties with respect to the subject matter herein and supersedes all prior negotiations, representations, or agreements, whether written or oral.

#### **10. Amendments**

Any amendments or modifications to this Agreement must be in writing and signed by both parties to be effective.

#### **11. Severability**

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall continue in full force and effect.

#### **12. Signatures and Acceptance**
