Contract Clauses:

Clause 1 – Agreement to Sell and Purchase

Seller agrees to sell and Buyer agrees to purchase the products or services described herein according to the terms of this Agreement.

Clause 2 – Price and Payment

The prices stated herein are fixed and not subject to change except by mutual written agreement. Payment shall be made as per the Payment Terms section.

Clause 3 – Delivery and Acceptance

Seller shall deliver the products or provide services in accordance with agreed schedules. Buyer shall inspect and accept or reject within a reasonable time.

Clause 4 – Warranties

Seller warrants that all products or services conform to specifications and are free of defects. Any warranties shall comply with applicable United States laws.

Clause 5 – Risk of Loss

Risk of loss or damage shall pass to Buyer upon delivery at the agreed delivery point.

Clause 6 – Taxes and Duties

All taxes, duties, and fees arising from the sale and purchase under this Agreement shall be handled as stipulated herein.

Clause 7 – Confidentiality

Both parties agree to keep confidential all non-public business and technical information exchanged under this

Agreement.

Clause 8 – Termination

This Agreement may be terminated by either party upon material breach if such breach remains uncured after written notice within the specified cure period.

Clause 9 – Limitation of Liability

Neither party shall be liable for incidental, consequential, or punitive damages except as expressly provided.

Clause 10 – Governing Law and Jurisdiction

This Agreement shall be governed by the laws of the State of _____. Parties consent to the exclusive jurisdiction of the courts located in _____ County, _____.

Clause 11 – Entire Agreement

This Agreement constitutes the entire agreement between parties and supersedes all prior agreements and understandings.

Clause 12 – Amendments

Any modifications or amendments must be in writing and signed by authorized representatives of both parties.

Clause 13 – Force Majeure

Neither party shall be liable for delays or failures due to causes beyond its reasonable control, including natural disasters, acts of government, or labor disputes.

Clause 14 – Notices

All notices shall be in writing and delivered as set forth in this Agreement, deemed given upon receipt.

Clause 15 – Severability

If any provision is found unenforceable, the remainder shall remain in full force and effect.

Clause 16 – Waiver

Failure to enforce any right shall not constitute a waiver of future enforcement.

Clause 17 – Assignment

Neither party may assign this Agreement without prior written consent of the other party.

Clause 18 – Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original.

Clause 19 – Compliance with Laws

Both parties shall comply with all applicable United States federal, state, and local laws and regulations.

Clause 20 – Signatures

This Agreement is signed by duly authorized representatives of each party as of the date indicated on the cover page.
