Clause 1 – Purpose of Agreement

Seller agrees to sell and Buyer agrees to purchase the puppy described above on the terms set forth in this Agreement. Seller represents that Seller has full right, title, and authority to sell the puppy and that no third party consent is required other than as expressly stated in this Agreement.

Clause 2 – Health and Vaccinations

Seller represents that the puppy has received age-appropriate vaccinations and has been examined by a licensed veterinarian. Seller shall provide Buyer with all available health records, vaccination certificates, and any applicable registration or pedigree documents at the time of sale.

Clause 3 – Condition; AS-IS WHERE-IS

Except as expressly stated in writing in this Agreement, the puppy is sold AS-IS, WHERE-IS, without any express or implied warranties, including without limitation any implied warranties of merchantability or fitness for a particular purpose under applicable law. Buyer acknowledges having had the opportunity to inspect the puppy and accepts the apparent condition subject only to rights provided in this Agreement.

Clause 4 – Buyer's Obligations

Buyer agrees to provide appropriate care, nutrition, medical treatment, and safe living conditions for the puppy. Buyer agrees not to sell, transfer, or otherwise dispose of the puppy to any third party without prior written consent of Seller.

Clause 5 – Return Policy

Buyer may return the puppy to Seller within ____ days from the date of purchase if the puppy is found to have a serious health condition that was not disclosed by Seller at the time of sale. In such case, Buyer shall provide a written statement from a licensed veterinarian confirming the condition. Upon return, Buyer shall be entitled to a refund of the purchase price, less any reasonable expenses incurred.

Clause 6 – Registration and Documentation

Seller shall provide Buyer with any applicable registration papers and pedigree documentation at the time of sale. Buyer agrees to complete any required registration and transfer of ownership promptly.

Clause 7 – No Breeding Warranty

Unless otherwise expressly agreed in writing, this sale is for a pet purpose only, and Buyer agrees not to breed the puppy. Any breeding rights or agreements must be separately documented.

Clause 8 – Liability

Seller shall not be liable for any injury, illness, or damages to the puppy that occur after the sale, except as expressly provided herein. Buyer assumes full responsibility for the care and well-being of the puppy upon transfer of possession.

Clause 9 – Governing Law

This Agreement shall be governed by the laws of the State of _____, without regard to conflict-of-law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

Clause 10 – Entire Agreement

This Agreement constitutes the entire agreement between Seller and Buyer with respect to the sale of the puppy and supersedes all prior negotiations, understandings, or agreements, whether oral or written. No amendment or modification shall be effective unless in writing and signed by both parties.

Clause 11 – Severability

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall continue in full force and effect.

Clause 12 – Notices

All notices required or permitted under this Agreement shall be in writing and delivered personally, by certified mail return receipt requested, or by nationally recognized overnight courier to the parties at their respective addresses set forth above or such other address as either party may designate by notice.

Clause 13 – Signature and Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.

Clause 14 – Health Guarantee

Seller guarantees that the puppy is in good health at the time of sale. Buyer shall have ____ hours/days to obtain a veterinary health examination. If a serious health issue is identified, Buyer must notify Seller immediately and provide veterinary documentation.

Clause 15 – Spay/Neuter Agreement

Buyer agrees to have the puppy spayed or neutered by the age of ____ months unless a breeding agreement is in place. Proof of procedure shall be provided to Seller.

Clause 16 – Transfer of Ownership

Ownership of the puppy transfers to Buyer upon full payment and delivery. Until such time, Seller retains ownership and possession rights.

Clause 17 – Health Records and Vet Care

Seller shall provide Buyer with all health records and vaccination history. Buyer agrees to maintain the puppy's health with regular veterinary care.

Clause 18 – Limitation of Damages

In no event shall Seller be liable for incidental, consequential, or special damages arising out of or related to this Agreement or the sale of the puppy.

Clause 19 – Dispute Resolution

Any dispute arising under or related to this Agreement shall be resolved by mediation or binding arbitration in accordance with the laws of the governing state.

Clause 20 – Acknowledgment

Buyer acknowledges having read, understood, and agreed to all terms and conditions of this Agreement.
