Salon Services Description:

The Salon agrees to provide hair and beauty services to the Client as detailed in the attached Schedule of Services. These services may include, but are not limited to, haircuts, styling, coloring, makeup application, nail care, and other cosmetic treatments as agreed upon by both parties. The Salon may update the Schedule of Services from time to time with prior notice to the Client.

Terms of Service:

1. Appointment Scheduling: Client agrees to schedule services in advance and arrive on time. Late arrivals may result in reduced service time or rescheduling. 2. Payment: Payment is due in full upon completion of services unless otherwise agreed in writing. Accepted payment methods include cash, credit/debit cards, and other methods as offered by the Salon. 3. Cancellations and No-shows: Cancellations must be made at least 24 hours prior to the appointment. No-shows or late cancellations may incur a fee as determined by the Salon. 4. Health and Safety: Client confirms they do not have any conditions that would contraindicate the services requested. Client agrees to notify the Salon of any allergies, sensitivities, or medical conditions prior to service. 5. Salon Liability: The Salon shall not be liable for any adverse reactions or results arising from services provided, except in cases of gross negligence or willful misconduct. 6. Personal Belongings: The Salon is not responsible for loss or damage to Client's personal items brought to the premises. 7. Confidentiality: The Salon agrees to keep Client's personal information confidential except as required by law or with Client's consent. 8. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflicts of law principles. 9. Dispute Resolution: Any dispute arising out of or relating to this Agreement shall be resolved first through good faith negotiation. If unresolved, the parties agree to mediation before pursuing litigation. 10. Entire Agreement: This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements. Amendments must be in writing and signed by both parties.

Client Representations and Warranties:

Client represents and warrants that they are at least 18 years old, have the legal capacity to enter this Agreement, and have disclosed any health conditions relevant to the services. Client agrees to indemnify and hold Salon harmless from any claims arising from failure to disclose such information.

Salon Responsibilities:

Salon agrees to provide services professionally and in accordance with industry standards. Salon will maintain a safe, sanitary environment compliant with all applicable health and safety regulations. Salon will handle Client information with confidentiality and integrity.

Term and Termination:

This Agreement shall commence upon execution and shall continue until terminated by either party with written notice. Salon reserves the right to terminate services immediately for Client misconduct or non-payment. Termination shall not relieve Client of any outstanding payment obligations.

Indemnification:

Each party agrees to indemnify, defend, and hold harmless the other party from any claims, damages, liabilities, and expenses arising out of breaches of this Agreement or negligence in connection with the services.

Force Majeure:

Neither party shall be liable for any failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, natural disasters, government actions, or pandemics.

Severability:

If any provision of this Agreement is held invalid or unenforceable, the remainder shall remain in full force and effect.

Acknowledgment:

Client acknowledges having read, understood, and agreed to the terms and conditions of this Agreement prior to execution.
