All content, materials, and deliverables created by the Service Provider under this Agreement shall be considered work made for hire, and all rights, title, and interest shall be transferred to the Client upon full payment. The Service Provider retains no rights to use the work except as agreed in writing.

Confidentiality:

Both parties agree to maintain the confidentiality of any proprietary or sensitive information obtained during the term of this Agreement and not to disclose such information without prior written consent, except as required by law.

Termination:

Either party may terminate this Agreement with written notice if the other party materially breaches any term herein and fails to cure such breach within a reasonable time. Upon termination, the Client shall pay for all services rendered up to the termination date.

Indemnification:

Each party agrees to indemnify, defend, and hold harmless the other from and against any claims, liabilities, damages, and expenses arising from their negligence or willful misconduct in connection with this Agreement.

Limitation of Liability:

In no event shall either party be liable for any indirect, incidental, consequential, special, or punitive damages arising out of or relating to this Agreement, even if advised of the possibility thereof.

Independent Contractor:

The Service Provider is an independent contractor and nothing in this Agreement shall be construed to create a partnership, joint venture, or employer-employee relationship.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflicts of law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

Dispute Resolution:

Any dispute arising out of or relating to this Agreement shall first be attempted to be resolved through good faith negotiation between the parties. If unresolved, the parties agree to mediation before resorting to litigation.

Entire Agreement:

This Agreement, including all attachments and exhibits, constitutes the entire agreement between the parties and supersedes all prior oral or written understandings. Any amendments must be in writing and signed by both parties.

Severability:

If any provision of this Agreement is found to be invalid or unenforceable, the remainder shall remain in full force and effect.

Waiver:

Failure to enforce any provision of this Agreement shall not constitute a waiver of future enforcement of that or any other provision.

Force Majeure:

Neither party shall be liable for delays or failure in performance due to causes beyond their reasonable control, including but not limited to acts of God, war, terrorism, strikes, or governmental actions.
