Clause 1 – Purpose of Agreement

Seller agrees to sell and Buyer agrees to purchase the snowmobile identified above, including all accessories, equipment, and documents (collectively, the “Snowmobile”), on the terms set forth herein. Seller warrants full right, title, and authority to convey the Snowmobile, free of all liens and encumbrances.

Clause 2 – Condition; AS-IS, WHERE-IS

Except as expressly stated in this Agreement, the Snowmobile is sold AS-IS, WHERE-IS, with all faults, without warranties of any kind, express or implied, including merchantability or fitness for a particular purpose. Buyer acknowledges the opportunity to inspect prior to purchase.

Clause 3 – Delivery and Risk of Loss

Risk of loss or damage passes to Buyer upon physical delivery of the Snowmobile at the agreed location. Delivery shall occur at the place designated by the parties. Until delivery, Seller is responsible for maintaining the Snowmobile’s condition.

Clause 4 – Purchase Price and Payment

The total purchase price shall be paid as follows: Buyer shall pay a deposit (if any) upon execution of this Agreement,

to be applied against the purchase price at closing. The balance shall be paid via wire transfer, cashier's check, or other agreed method at closing.

Clause 5 – Title and Transfer

Seller shall provide to Buyer a clear and marketable title free of liens at closing. All documents necessary for title transfer and registration shall be delivered by Seller at closing.

Clause 6 – Taxes and Fees

Buyer is responsible for all sales tax, registration fees, and other governmental costs associated with the purchase, ownership, and registration of the Snowmobile. Seller shall pay any fees to clear existing liens.

Clause 7 – Representations and Warranties

Seller represents that the Snowmobile is free of undisclosed defects and encumbrances and that all information provided is true and accurate to the best of Seller's knowledge.

Clause 8 – Inspection and Acceptance

Buyer has the right to inspect the Snowmobile prior to closing. Buyer accepts the Snowmobile in its current condition subject to rights stated herein.

Clause 9 – Default and Remedies

If Buyer fails to perform, Seller may retain deposits as liquidated damages. If Seller breaches, Buyer may seek specific performance or damages as allowed by law.

Clause 10 – Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____. Parties consent to venue in the appropriate state or federal courts located in _____ County, _____.

Clause 11 – Entire Agreement and Amendments

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations. Amendments must be in writing and signed by both parties.

Clause 12 – Notices

All notices under this Agreement shall be in writing and delivered by hand, certified mail, overnight courier, or electronic means with confirmation.

Clause 13 – Severability

If any provision is held invalid or unenforceable, the remainder shall remain in full force and effect.

Clause 14 – Confidentiality

The terms of this Agreement and related information shall be kept confidential except as required by law or agreed by both parties.

Clause 15 – Counterparts

This Agreement may be executed in counterparts, including electronically, each of which is deemed an original.

Clause 16 – Additional Provisions

Any additional provisions or agreements shall be set forth in attached schedules incorporated herein.
