Terms and Conditions:

Clause 1 – Scope of Services

Service Provider agrees to perform snow removal and de-icing services as described above, in a professional and timely manner, consistent with industry standards.

Clause 2 – Access and Safety

Client shall provide Service Provider with reasonable access to the service locations and ensure that areas are free of obstacles or hazards that could impede performance or cause damage.

Clause 3 – Weather Conditions and Scheduling

Services will be provided based on weather events that produce accumulations of snow or ice requiring removal, subject to scheduling priorities and operational conditions.

Clause 4 – Liability and Insurance

Service Provider shall maintain insurance coverage as required by law and shall be liable for damages directly caused by negligence or willful misconduct. Client shall notify Service Provider promptly of any claims.

Clause 5 – Indemnification

Each party agrees to indemnify and hold harmless the other from any claims, damages, or liabilities arising out of

breaches of this Agreement or negligent acts or omissions.

Clause 6 – Term and Termination

This Agreement shall remain in effect until completion of services or termination by either party upon written notice. Client shall pay for all services rendered through termination.

Clause 7 – Force Majeure

Neither party shall be liable for failure or delay in performance due to causes beyond reasonable control, including acts of God, governmental restrictions, or severe weather.

Clause 8 – Dispute Resolution

Any disputes shall be resolved through good faith negotiation, and if unresolved, through binding arbitration in accordance with the rules of a recognized arbitration association.

Clause 9 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the applicable state within the United States, without regard to conflict-of-law principles.

Clause 10 – Entire Agreement

This Agreement constitutes the entire understanding between the parties with respect to its subject matter and supersedes all prior agreements, oral or written.

Clause 11 – Amendments

Any amendments must be in writing and signed by authorized representatives of both parties.

Clause 12 – Notices

All notices shall be in writing and delivered by hand, certified mail, nationally recognized overnight courier, or email with confirmation, to the addresses listed above.

Clause 13 – Severability

If any provision is held invalid or unenforceable, the remaining provisions shall continue in full force and effect.

Clause 14 – Assignment

Neither party may assign or transfer this Agreement without prior written consent of the other party.

Clause 15 – Waiver

Failure to enforce any provision shall not constitute waiver of future enforcement.

Clause 16 – Independent Contractor

Service Provider is an independent contractor and not an employee, partner, or joint venturer of Client.

Clause 17 – Confidentiality

Parties shall maintain confidentiality of proprietary information and not disclose to third parties except as required by law.

Clause 18 – Equipment and Materials

Service Provider shall furnish all equipment, labor, and materials necessary to perform the services unless otherwise agreed.

Clause 19 – Safety Compliance

Service Provider shall comply with all applicable safety laws, regulations, and standards in performing services.

Clause 20 – Signatures

This Agreement may be executed in counterparts and electronically. The parties have executed this Agreement as of the date first written above.
