## Clause 1 – Purpose of Agreement

The Donor agrees to provide sperm specimens to the Recipient or Recipient's authorized agent for the purpose of assisted reproduction, subject to the terms and conditions of this Agreement.

## Clause 2 – Donor Representations and Warranties

The Donor represents and warrants that he is over the age of 21, is in good health, and has disclosed any known hereditary or communicable diseases. The Donor affirms that the specimens are provided voluntarily and without coercion.

## Clause 3 – Health Screening and Testing

The Donor shall undergo all required medical and genetic screening tests in accordance with applicable guidelines and laws. The Donor agrees to provide truthful information and consents to such testing.

## Clause 4 – Confidentiality and Privacy

Both parties agree to keep confidential all information relating to the Donor and Recipient, except as required by law or necessary for medical treatment.

## Clause 5 – No Parental Rights

The Donor relinquishes and waives any and all parental rights and obligations with respect to any child conceived from

the donated sperm. The Recipient shall be the sole legal parent(s) of such child.

**Clause 6 – Compensation**

The Donor will receive the agreed compensation as outlined above. This compensation is not for the sale of human tissue but for time, inconvenience, and related expenses.

**Clause 7 – Indemnification**

The Donor agrees to indemnify, defend, and hold harmless the Recipient from any claims arising from the Donor's breach of representations or warranties in this Agreement.

**Clause 8 – Use and Disposal of Specimens**

Recipient has sole discretion over the use, storage, or disposal of the donated specimens. The Donor has no rights to direct or control such use.

**Clause 9 – Governing Law and Venue**

This Agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_. Any disputes shall be resolved exclusively in the state or federal courts located in \_\_\_\_\_ County, \_\_\_\_\_.

**Clause 10 – Entire Agreement**

This document constitutes the entire agreement between the parties with respect to its subject matter and supersedes all prior agreements, understandings, and negotiations.

**Clause 11 – Amendment and Waiver**

No amendment or waiver of any provision of this Agreement shall be effective unless in writing and signed by both parties.

**Clause 12 – Severability**

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

**Clause 13 – Notices**

All notices under this Agreement shall be in writing and deemed properly given when delivered by hand, certified mail return receipt requested, recognized overnight courier, or electronic means with confirmation.

**Clause 14 – No Guarantee of Pregnancy**

The Recipient acknowledges that the Donor makes no guarantees, warranties, or promises regarding the success of pregnancy or the health of any child born from the donation.

**Clause 15 – Release of Liability**

The Donor releases the Recipient and any medical providers from any liability related to the use of the donated specimens, including but not limited to any genetic conditions or health issues.

**Clause 16 – Signatures; Counterparts**

This Agreement may be executed in counterparts, each of which shall be deemed an original. Electronic signatures shall be considered valid and binding.
