Breeding Terms and Conditions:

1. Stud service fee: _____ USD
2. Payment terms: _____
3. Stud service includes:
 - Natural breeding or artificial insemination as agreed.
 - Health and vaccination documentation provided.
4. Bitch Owner agrees to ensure bitch is in proper estrus and health condition for breeding.
5. Breeding attempts:
 - Up to _____ natural breeding attempts or artificial inseminations during the current heat cycle.
 - Additional attempts require additional fees and mutual agreement.
6. Pregnancy guarantee:
 - If bitch does not conceive after _____ days post-breeding, a repeat breeding will be provided at no additional stud fee.
 - Repeat breeding does not guarantee pregnancy.
7. Health warranty:
 - Stud dog is free from hereditary diseases and contagious conditions at time of breeding.
 - Bitch Owner confirms bitch is healthy and free from diseases transmissible to Stud dog.
8. Liability:
 - Neither party shall be liable for indirect, consequential, or incidental damages arising from this Agreement.
 - Stud Dog Owner is not responsible for care, maintenance, or health of the bitch beyond breeding service.
9. Ownership and registration of offspring:
 - Puppies born from this breeding are the sole property of the Bitch Owner unless otherwise agreed.

Clause 13 – Health Certifications and Testing

Both parties agree to provide copies of current health certifications, including but not limited to vaccinations, genetic testing, and any required health clearances for the stud dog and bitch prior to breeding. Failure to provide these documents may result in termination of this Agreement.

Clause 14 – Breeding Dates and Location

Breeding shall take place at a mutually agreed time and location. The Bitch Owner shall be responsible for all transportation costs unless otherwise agreed. Stud Dog Owner agrees to make the stud dog available for breeding during the agreed timeframe.

Clause 15 – Care and Maintenance

The Bitch Owner is responsible for the care and maintenance of the bitch at all times. The Stud Dog Owner shall maintain the stud dog's health and condition and provide all necessary documentation.

Clause 16 – Warranties and Representations

Each party represents and warrants that it has full authority to enter into this Agreement, and that the dog(s) involved are free of contagious diseases and have no known hereditary defects that would affect breeding.

Clause 17 – Confidentiality

The parties agree to keep all personal information and breeding details confidential, except where disclosure is required by law or mutually agreed.

Clause 18 – Assignment

This Agreement is binding upon and inures to the benefit of the parties and their respective heirs, executors, administrators, and permitted assigns. Neither party may assign this Agreement without prior written consent of the other.

Clause 19 – Dispute Resolution

In the event of dispute, parties agree first to attempt mediation before pursuing litigation. This Agreement does not waive any party's right to seek injunctive relief or other remedies as provided by law.

Clause 20 – Force Majeure

Neither party shall be liable for failure to perform if such failure is due to causes beyond their reasonable control, including but not limited to acts of God, governmental acts, or natural disasters.

Clause 21 – Signatures and Execution

This Agreement may be executed in counterparts, each of which shall be deemed an original. Electronic signatures shall be treated as originals for all purposes and have the same legal effect.
