Contract Terms and Conditions:

1. Subscription Grant

The Service Provider hereby grants to the Subscriber a non-exclusive, non-transferable subscription to access and use the services described herein during the Subscription Term, subject to the terms and conditions of this Contract.

2. Term and Renewal

The Subscription Term shall commence on the Effective Date and continue for the period specified in the Service Details. The subscription shall automatically renew for successive terms unless either party provides prior written notice of termination as specified herein.

3. Fees and Payment

Subscriber agrees to pay all fees set forth in the Payment Information punctually. Failure to pay fees when due shall constitute a material breach and may result in suspension or termination of service.

4. Subscriber Obligations

Subscriber shall use the service in compliance with all applicable laws and regulations. Subscriber shall not engage in unauthorized use, including but not limited to reselling, sharing login credentials, or reverse engineering the service.

5. Service Provider Obligations

Service Provider shall use commercially reasonable efforts to provide the service in accordance with the described plan. Service Provider makes no warranties beyond those expressly stated herein.

6. Confidentiality

Each party agrees to maintain the confidentiality of the other party's confidential information and to use such information only for purposes of performing under this Contract.

7. Termination

Either party may terminate this Contract by providing the other party with written notice in accordance with the notice provisions herein. Termination shall not affect obligations accrued prior to termination.

8. Limitation of Liability

To the maximum extent permitted by law, neither party shall be liable for indirect, incidental, special, consequential, or punitive damages arising out of or related to this Contract.

9. Indemnification

Subscriber agrees to indemnify and hold harmless the Service Provider from any claims, losses, or damages arising out of Subscriber's misuse of the service or breach of this Contract.

10. Governing Law and Venue

This Contract shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflict of law principles. The parties consent to exclusive jurisdiction and venue in the state or federal courts located in _____ County, _____.

11. Entire Agreement

This Contract constitutes the entire agreement between the parties and supersedes all prior agreements, understandings, and communications, whether oral or written.

12. Amendments

Any amendments to this Contract must be in writing and signed by both parties.

13. Notices

All notices required or permitted under this Contract shall be in writing and deemed delivered upon receipt when sent via certified mail, courier, or email to the addresses provided herein.

14. Severability

If any provision of this Contract is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

15. Waiver

Failure by either party to enforce any provision shall not be deemed a waiver of future enforcement of that or any other provision.

16. Force Majeure

Neither party shall be liable for failure or delay in performance due to causes beyond its reasonable control including but not limited to acts of God, war, terrorism, labor disputes, or governmental action.

17. Assignment

Subscriber may not assign or transfer this Contract without the prior written consent of the Service Provider.

18. Relationship of Parties

The parties are independent contractors, and nothing herein shall be construed to create a partnership, joint venture, or agency relationship.

19. Counterparts and Electronic Signatures

This Contract may be executed in counterparts and by electronic signature, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.

20. Compliance with Laws

Subscriber agrees to comply with all applicable laws, regulations, and rules related to use of the service and performance under this Contract.
