Services Provided:

The Agency agrees to represent the Talent in seeking and procuring engagements in the entertainment, modeling, and related industries, including but not limited to auditions, bookings, and promotional events. The Agency shall use reasonable efforts to secure work for the Talent but does not guarantee any minimum number of engagements.

Compensation and Fees:

Talent agrees to pay the Agency a commission of _____% of all gross compensation earned by Talent from engagements secured by the Agency under this contract. Payment shall be due within _____ days of Talent's receipt of such compensation. Agency shall provide Talent with detailed statements of commissions earned and payments received.

Exclusivity:

Talent grants the Agency exclusive rights to represent Talent for the duration of this contract in the agreed-upon territory and industries. Talent shall not engage other agents or representatives for the same services without prior written consent of the Agency.

Term and Termination:

This Contract shall commence on the Start Date and continue until the End Date unless terminated earlier by either party with at least thirty (30) days written notice. Termination does not relieve Talent from obligations to pay commissions on engagements secured prior to termination.

Talent Obligations:

Talent agrees to provide truthful and accurate information, attend auditions and engagements punctually, and maintain professional conduct. Talent shall disclose any conflicts or commitments that may affect availability.

Agency Obligations:

Agency agrees to exercise good faith and reasonable efforts to promote Talent's career, negotiate contracts diligently, and keep Talent informed of opportunities.

Confidentiality:

Both parties agree to keep confidential all proprietary information, trade secrets, and personal information obtained during the course of this Contract, except as required by law or with written consent.

Indemnification:

Talent agrees to indemnify and hold harmless Agency from any claims, damages, or liabilities arising from Talent's breach of this Contract or misconduct. Agency shall not be liable for any indirect, incidental, or consequential damages.

Governing Law and Dispute Resolution:

This Contract shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflicts of law principles. Any disputes arising hereunder shall be resolved through binding arbitration in _____ County, _____, in accordance with the rules of the American Arbitration Association.

Miscellaneous:

This Contract constitutes the entire agreement between Agency and Talent, superseding all prior negotiations or agreements, whether written or oral. Any amendments must be in writing and signed by both parties. If any provision is deemed invalid, the remainder shall remain enforceable. No waiver of any breach shall be deemed a waiver of subsequent breaches.
