### Clause 1 – Services to be Provided

The Tattoo Artist agrees to provide tattoo services as described in the Tattoo Details section above. The Client agrees to cooperate and follow all instructions provided by the Tattoo Artist during the service.

### Clause 2 – Health and Safety; Assumption of Risk

Client represents that they are in good health and do not have any conditions that would contraindicate tattooing. Client assumes all risks related to the tattoo procedure, including but not limited to allergic reactions, infections, and complications.

### Clause 3 – Consent and Authorization

Client hereby consents to the tattoo procedure and authorizes the Tattoo Artist to perform the services described herein. Client affirms that they are of legal age to consent or have obtained parental/guardian consent as required by law.

### Clause 4 – No Guarantees

The Client acknowledges that results may vary and that the Tattoo Artist makes no guarantees regarding the

appearance, longevity, or outcome of the tattoo.

**Clause 5 – Payment and Deposits**

Client agrees to pay the total price as set forth above. Deposits are non-refundable but may be applied toward the total price. Balance is due upon completion of the tattoo service.

**Clause 6 – Cancellation and Rescheduling**

Client agrees to provide at least 48 hours notice for cancellations or rescheduling. Failure to do so may result in forfeiture of the deposit.

**Clause 7 – Aftercare Instructions**

Tattoo Artist will provide aftercare instructions which Client agrees to follow strictly to ensure proper healing. Failure to follow aftercare instructions may affect the final result.

**Clause 8 – Liability Waiver**

Client releases the Tattoo Artist and Studio from any liability arising from the tattoo procedure except in cases of gross negligence or intentional misconduct.

**Clause 9 – Intellectual Property**

All tattoo designs created by the Tattoo Artist remain the intellectual property of the Tattoo Artist unless otherwise agreed in writing.

**Clause 10 – Governing Law and Venue**

This Agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_. The parties consent to exclusive jurisdiction and venue in the state and federal courts located in \_\_\_\_\_ County, \_\_\_\_\_.

**Clause 11 – Entire Agreement**

This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements and understandings. No amendment shall be effective unless in writing and signed by both parties.

**Clause 12 – Severability**

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall continue in full force and effect.

**Clause 13 – Acknowledgment of Understanding**

Client acknowledges that they have read and fully understand this Agreement, have had the opportunity to ask questions, and agree to be bound by its terms.

**Clause 14 – Photography and Media Release**

Client consents to the Tattoo Artist taking photographs or videos of the tattoo for promotional purposes unless Client explicitly opts out in writing.

**Clause 15 – No Warranty on Healing**

Tattoo Artist does not warrant the healing process or final appearance of the tattoo. Healing varies by individual and Client assumes responsibility.

**Clause 16 – Allergies and Skin Conditions**

Client agrees to disclose any allergies, skin conditions, or sensitivities prior to the tattoo procedure.

**Clause 17 – Refunds and Touch-Ups**

Refunds are not provided. Touch-ups may be offered at the sole discretion of the Tattoo Artist and are not guaranteed.

**Clause 18 – Minors**

If Client is a minor, this Agreement must be signed by a parent or legal guardian, and all legal requirements must be met.

**Clause 19 – Confidentiality**

Both parties agree to keep all personal information confidential except as required by law.

**Clause 20 – Signatures and Counterparts**

This Agreement may be executed in counterparts, each of which shall be deemed an original but all of which constitute one and the same instrument. Electronic signatures shall be deemed as valid as original signatures.
