Liability and Indemnification:

Team Organization shall not be liable for injuries or damages incurred by team members except where caused by gross negligence or willful misconduct. Team members agree to indemnify and hold harmless the organization from claims arising out of their actions during team activities.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the United States and the applicable state law where the Team Organization is headquartered. Any disputes arising under this Agreement shall be resolved through binding arbitration in that jurisdiction unless otherwise mutually agreed.

Entire Agreement and Amendments:

This Agreement constitutes the entire agreement between the parties and supersedes all prior understandings. Modifications or amendments must be made in writing and signed by all parties.
