Service Provider shall perform services in a professional and workmanlike manner. Neither party shall be liable for indirect, incidental, or consequential damages. Client agrees to indemnify and hold harmless Service Provider from any claims arising from Client's use of the delivered work.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to its conflict of law principles.
