1. Engagement

Client hereby engages Voice Over Artist to provide voice over services as described in this Agreement, and Artist agrees to provide such services under the terms and conditions herein.

2. Term

This Agreement shall commence upon execution by both parties and shall continue until the completion and delivery of the voice over recordings as specified.

3. Services and Deliverables

Artist shall record and deliver the voice over content according to the script(s) and specifications provided by Client. Deliverables shall be provided in the agreed formats and within the delivery deadlines.

4. Revisions

Client is entitled to request up to two rounds of reasonable revisions without additional charge. Additional revisions or changes beyond those agreed may be subject to extra fees.

5. Compensation

Client agrees to pay Artist the Total Fee specified above. Payment shall be made according to the Payment Schedule and Payment Method agreed upon.

6. Ownership and License

Upon full payment, Artist grants Client a non-exclusive, worldwide, perpetual license to use the delivered recordings for the intended purpose. Artist retains the right to use the recordings for portfolio and promotional purposes.

7. Confidentiality

Both parties agree to keep confidential any proprietary or sensitive information disclosed during the course of this Agreement.

8. Representations and Warranties

Artist represents that the recordings are original, do not infringe any third party rights, and that Artist has full authority to grant the license herein.

9. Indemnification

Each party agrees to indemnify and hold harmless the other from any claims arising out of breach of this Agreement or violation of applicable laws.

10. Termination

Either party may terminate this Agreement with written notice if the other party materially breaches any term and fails to cure within a reasonable period. Upon termination, Client shall pay for all services rendered up to termination.

11. Independent Contractor

Artist is an independent contractor and not an employee or agent of Client. Nothing herein shall be construed to create any employer-employee relationship.

12. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. The parties consent to exclusive jurisdiction and venue in the state and federal courts located in _____ County, _____.

13. Entire Agreement

This Agreement constitutes the entire understanding between the parties, superseding all prior agreements and understandings. Any amendments must be in writing and signed by both parties.

14. Severability

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall continue in full force and effect.

15. Force Majeure

Neither party shall be liable for failure or delay in performance due to causes beyond reasonable control, including but not limited to acts of God, war, or governmental actions.

16. Notices

All notices under this Agreement shall be in writing and deemed given upon delivery by hand, certified mail, or recognized overnight courier to the addresses provided.

17. Waiver

Failure to enforce any provision of this Agreement shall not constitute a waiver of future enforcement of that or any other provision.

18. Assignment

Neither party may assign or transfer rights or obligations under this Agreement without prior written consent of the other party, except to successors or affiliates.

19. Non-Disparagement

Both parties agree not to make any statements that negatively impact the reputation or business of the other.

20. Signatures

This Agreement may be executed in counterparts, including by electronic means, each of which shall be deemed an original and all of which together constitute one agreement.
