Terms and Conditions:

1. Scope of Services

The Service Provider agrees to provide catering services as described in the Menu and Services section for the Client's event, including but not limited to food preparation, delivery, setup, and cleanup.

2. Client Obligations

The Client agrees to provide accurate guest count, event details, and any special dietary requirements in a timely manner. The Client is responsible for providing a suitable venue and necessary permits.

3. Cancellation and Refunds

Cancellations made by the Client must be communicated in writing. Deposits are non-refundable unless the Service Provider cancels the event. Refund policies on the balance depend on the timing of cancellation.

4. Liability

The Service Provider shall maintain appropriate insurance coverage but is not responsible for any damage, loss, or injury occurring at the event venue beyond its direct control.

5. Food Safety and Quality

The Service Provider will comply with all applicable health and safety regulations. The Client acknowledges that food prepared offsite is perishable and accepts delivery at the agreed time.

6. Force Majeure

Neither party shall be liable for delays or failure to perform due to causes beyond their reasonable control, including but not limited to natural disasters, government restrictions, or other emergencies.

7. Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the United States and the State of _____. Any disputes arising hereunder shall be resolved exclusively in the state or federal courts located in _____ County, _____.

8. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements or understandings, written or oral, relating to the subject matter herein.

9. Amendments

Any modification or amendment to this Agreement must be in writing and signed by both parties to be valid and enforceable.

10. Independent Contractors

The parties acknowledge that the Service Provider and Client are independent contractors and that this Agreement does not constitute a partnership, joint venture, or employment relationship.

11. Indemnification

Each party agrees to indemnify and hold harmless the other from any claims, damages, or expenses arising out of their respective negligence or willful misconduct.

12. Non-Assignability

Neither party shall assign or transfer its rights or obligations under this Agreement without the prior written consent of the other party.

13. Confidentiality

The parties agree to keep confidential and not disclose any proprietary or sensitive information obtained during the course of this Agreement.

14. Severability

If any provision of this Agreement is found to be unenforceable, the remaining provisions shall remain in full force and effect.

15. Notices

All notices under this Agreement must be in writing and delivered by hand, certified mail, recognized courier, or electronic means with confirmation of receipt to the addresses specified herein.

16. Waiver

Failure to enforce any provision shall not constitute a waiver of future enforcement of that or any other provision.

17. Execution

This Agreement may be executed in counterparts, each of which shall be deemed an original, together constituting one agreement.

18. Compliance

Each party agrees to comply with all applicable laws, regulations, and ordinances related to the performance of this Agreement.

19. Dispute Resolution

In the event of a dispute, the parties agree first to attempt good faith negotiations before pursuing legal remedies.

20. Signatures
