If cancellation occurs more than 30 days before the event date(s), the deposit will be refunded minus \$100 administrative fee. Cancellations made within 30 days of the event date(s) result in forfeiture of deposit. If Florist cancels, all monies paid by Client will be refunded in full.

Cancellation notices must be delivered via email or certified mail.

**Limitation of Liability:**

Florist's liability for any claim related to the services provided shall not exceed the total amount paid by Client under this Agreement. Florist shall not be liable for any indirect, incidental, consequential, or punitive damages. Client agrees to indemnify and hold Florist harmless from any claims arising from Client's conduct or event conditions.

**Force Majeure:**

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, war, terrorism, government restrictions, labor disputes, or natural disasters. In such event, the parties shall agree to reschedule or terminate this Agreement without penalty.

**Governing Law and Venue:**

This Agreement shall be governed by and construed in accordance with the laws of the United States and the state in which the event takes place, without regard to conflict of law principles. Any disputes arising under this Agreement shall be subject to exclusive jurisdiction and venue in the state or federal courts located within that state.

**Entire Agreement and Amendments:**

This Agreement, including any attachments or addenda, constitutes the entire understanding between the parties and supersedes all prior negotiations, representations, or agreements, whether written or oral. Any amendments or modifications must be in writing and signed by both parties to be effective.

**Severability:**

If any provision of this Agreement is found to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.
